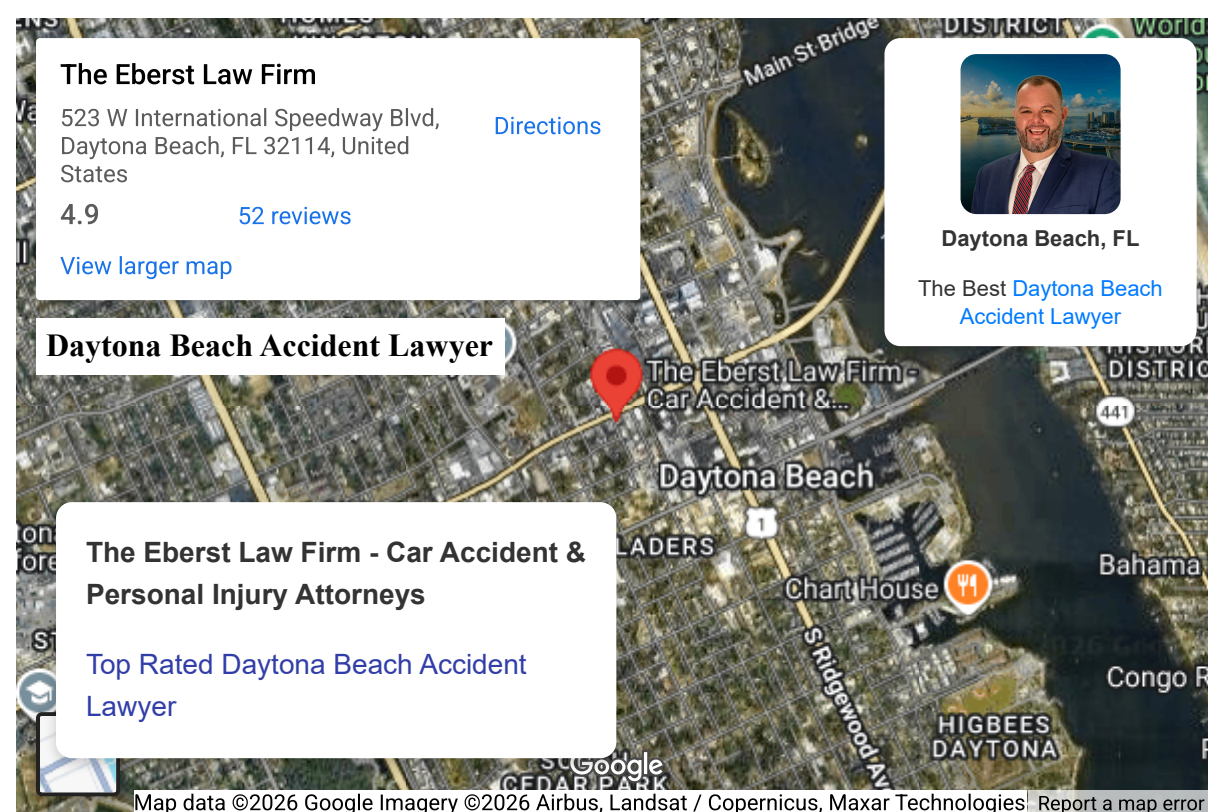

<p>The mean is the total of the numbers divided by how many numbers there are.</p> <p>To work out the mean:</p> <p>1. Add up all the numbers. <math>7 + 9 + 11 + 6 + 13 + 6 + 6 + 3 + 11 = 72</math></p> <p>2. Divide the answer by how many numbers there are. There are 9 numbers. <math>72 \div 9 = 8</math></p> <p>So the mean value is 8.</p>	<p>The median is the middle value.</p> <p>To work out the median:</p> <p>1. Put the numbers in order: 3 6 6 6 7 9 11 11 13</p> <p>2. The number in the middle of the list is the median.</p> <p>So the median value is 7.</p> <p>If there are two middle values, the median is halfway between them.</p>	<p>The mode is the value that appears the most.</p> <p>To work out the mode:</p> <p>1. Put the numbers in order: 3 6 6 6 7 9 11 11 13</p> <p>2. Look for the number that appears the most. 6 appears more than any other number.</p> <p>So the mode value is 6.</p>	<p>The range is the difference between the biggest and the smallest number.</p> <p>To work out the range:</p> <p>1. Put the numbers in order: 3 6 6 6 7 9 11 11 13</p> <p>2. Subtract the smallest number from the biggest number: <math>13 - 3 = 10</math></p> <p>So the range of this set of numbers is 10.</p>
