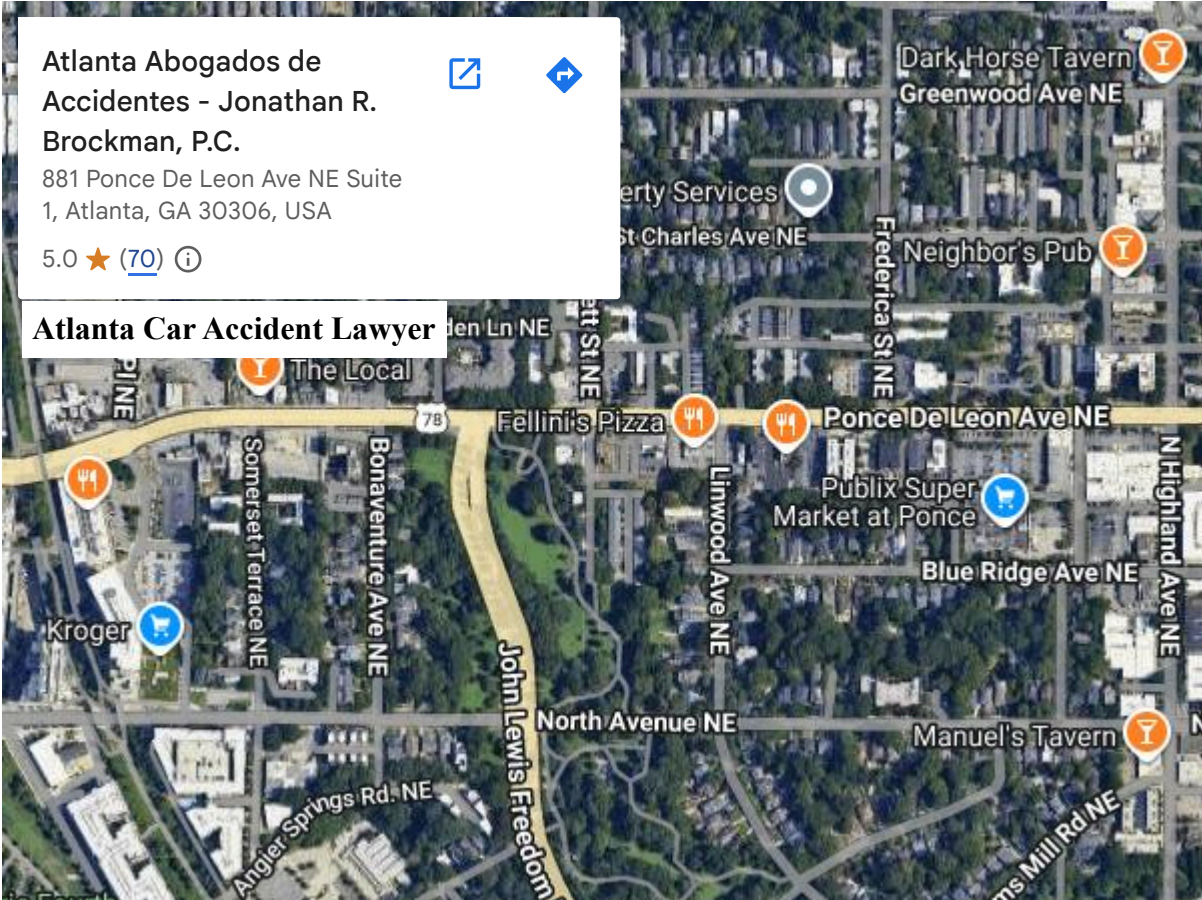

Pain and suffering
