

What Anion Gap Measures

The **anion gap** is a practical overview of **acid-base balance** from a standard **electrolyte panel**. It is not a literal measurement of a single substance. Instead, it is a calculated value that assists clinicians look for hidden acids in the blood and identify an **acid-base disorder** that may not be apparent from other numbers alone.

Most of the time, the calculation uses **sodium**, **chloride**, and bicarbonate-related values from **serum chemistry**. Because these measured **electrolytes** do not account for every charged particle in the bloodstream, the result leaves a “gap” that can point toward **acid accumulation** or another form of **metabolic derangement**.

Low albumin is frequent in CKD, and it can mask the true degree of acid-base imbalance. As **serum albumin** is a key unmeasured anion, a reduced albumin level can make the measured anion gap look falsely normal or only mildly elevated. That is why many clinicians use a **corrected anion gap** rather than the raw number alone.

Correcting for albumin enhances the clinical usefulness of the result. If albumin is low, some of the gap is “missing” merely because there is less negative **protein** in the blood. Correcting for this can uncover an underlying high gap metabolic problem that would otherwise be missed.

This is particularly important in chronic kidney disease, where poor nutrition, inflammation, and protein losses can all lower albumin. A corrected result offers better context for the true acid-base status and lowers the chance of missing **metabolic acidosis**.

Frequent Causes of Elevated Anion Gap in CKD

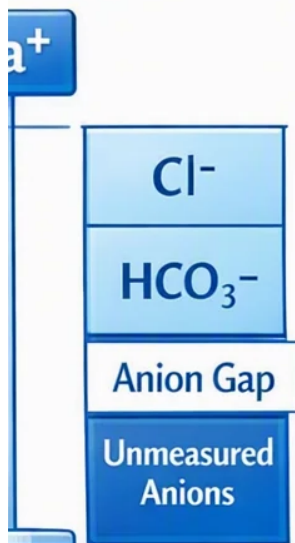

An arterial blood gas helps determine whether the patient has true acidemia or alkalemia. A low pH indicates active acidosis, while the base excess can show how severe the metabolic component is. 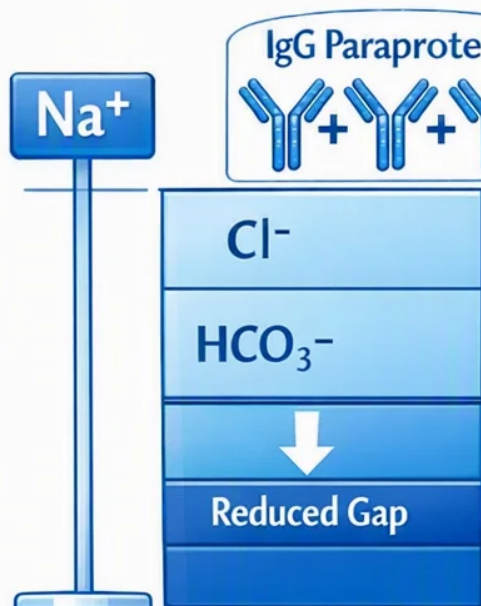
