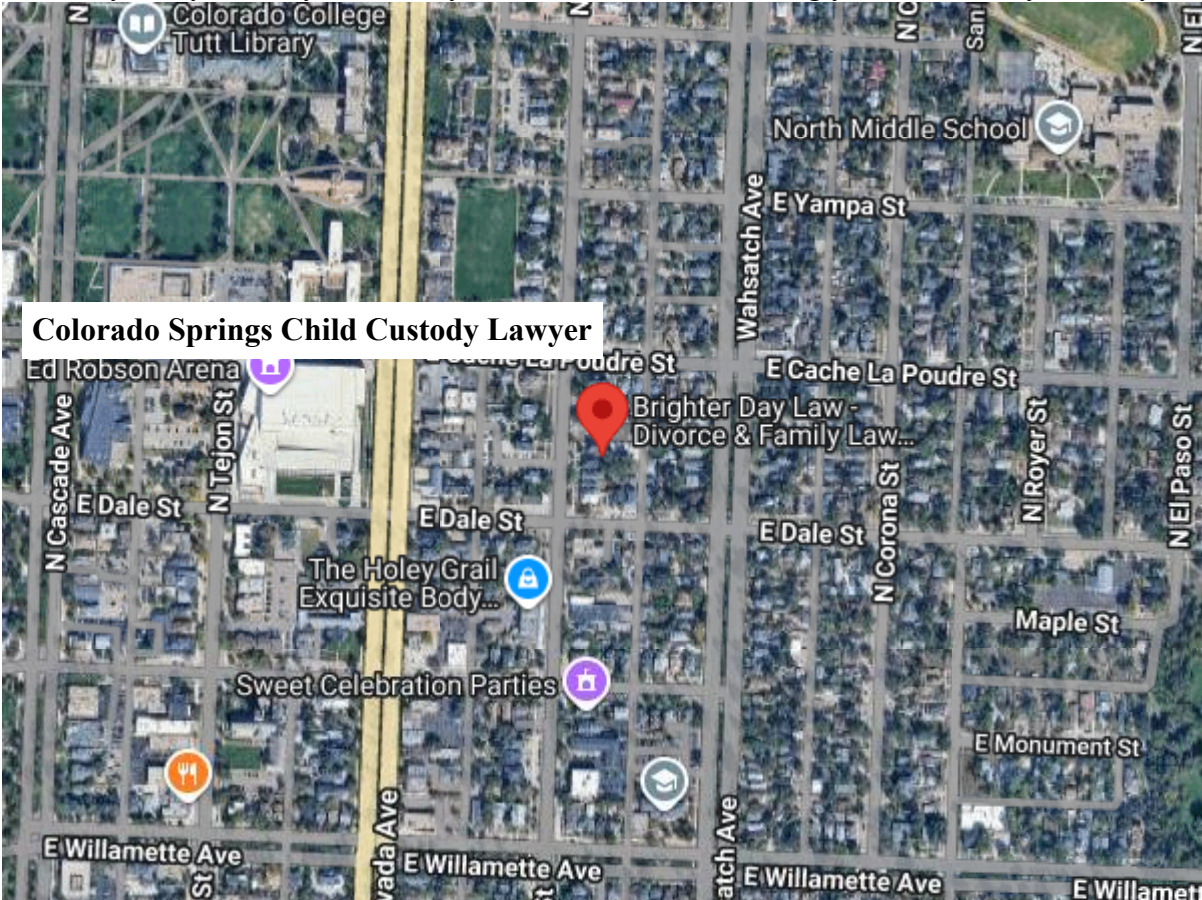

% THAT RECEIVED FULL AMOUNT ●

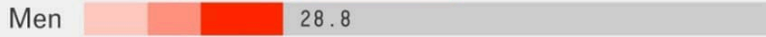
