The median is 4

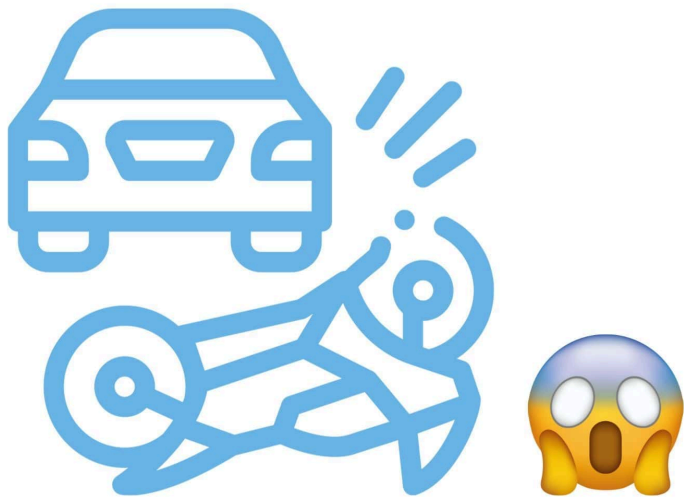
